Dear Sir or Madam,

I write today to provide you with information on ESB's proposed Irish offshore wind projects and to seek your engagement if you believe any of these projects could affect your activities.

ESB has been Ireland's foremost energy company since it was established in 1927, driven by an unwavering commitment to power society forward and now aiming to deliver a clean energy future for our customers and the communities we serve. We realise the importance of offshore wind in tackling climate change and delivering this clean energy, and we hope to take advantage of Ireland's unique offshore wind capability given its prime location on the western fringe of Europe.

We are currently in the early stages of development of six offshore wind projects around the Irish coast and, for the past 2 years, have been engaging with marine stakeholders and local communities to make them aware of our proposals and to seek their input. ESB is also minority shareholder in the Oriel Offshore Wind project off County Louth – that project is being led by our project partner, Parkwind.

In addition to face-to-face engagement, for each of ESB's offshore wind projects we have created and hosted online virtual consultation rooms and we have held project webinar and Question & Answer sessions as well as 3-day public exhibitions. We also actively participate in various offshore wind industry committees and working groups. Even with this range of engagement, we are very conscious that we are still not reaching everyone that could be affected by our projects. Accordingly, we have taken the decision to write directly to you and to seek your input if you believe our activities could affect yours or those of the people you represent.

Overleaf you will find a map illustrating the six proposed ESB-led sites and the study areas for each (shaded orange) as applied for in our Foreshore Licence applications. We have also included some boundary point coordinates for each site to assist you in determining where the sites are located relative to your area of interest. We plan to commence site-specific meetings with interested parties over the coming months and would ask, if you wish us to engage with you, that you complete the section at the bottom and return it to us **as soon as possible** in the prepaid envelope provided.

At any future face-to-face meetings we will be happy to provide further specific site locational and technical information, envisaged project timelines, proposed upcoming survey activity, etc. A key element of those meetings will also be you informing us on how any of these projects might affect your activities – it is essential we have a full understanding of this aspect.

We trust that the information contained in this letter offers a useful high-level insight into ESB's Offshore Wind portfolio. At ESB, we endeavour to develop our projects in a transparent and honest manner, with the ultimate goal of coexisting with other marine industries and activities. We very much welcome your feedback and queries to help us achieve this goal.

We look forward to hearing from you.


